Count 1 Child Molestation In The Third Degree

That the defendant SALVADOR DIAZ-GARCIA in King County, Washington, on or about June 25, 2017, being at least 48 months older than A.J.S. (12/12/02), had sexual contact for the purpose of sexual gratification with A.J.S. (12/12/02), who was 14 years old and was not married to and not in a state registered domestic partnership with Salvador Diaz-Garcia;

Contrary to RCW 9A.44.089, and against the peace and dignity of the State of Washington.

3 PROSECUTING ATTORNEY CASE SUMMARY AND REQUEST FOR BAIL AND/OR  
4 CONDITIONS OF RELEASE

5 The State incorporates by reference the Certification for Determination of Probable Cause  
6 prepared by Detective Marylisa Priebe-Olson of the King County Sheriff's Office for case  
7 number C17034043.

8  
9 Pursuant to CrR 2.2(b)(2)(ii) and (iv), the State requests a warrant because the defendant  
10 is currently in custody and is likely to commit a violent offense. The State requests bail set in the  
11 amount of \$100,000.00. The defendant is currently in custody on a Rape 2 and Assault 2. That  
12 brutal assault occurred within hours of this sexual assault. The defendant approached our victim,  
13 fourteen year old girl, and sexually assaulted her. The victim screamed and yelled and the  
14 defendant ran off. The defendant then went to a neighboring complex and brutally attacked and  
15 raped another young girl. The State is extremely concerned for the defendant's brazen, bold, and  
16 violent behavior towards young women. The State is seeking a Sexual Assault Protection Order  
17 for the victim as well as a no contact order with all minors.

2 CERTIFICATION FOR DETERMINATION OF PROBABLE CAUSE

3 That Marylisa Priebe-Olson is a(n) Detective with the King County  
4 Sheriff's Office and has reviewed the investigation conducted in the King  
County Sheriff's case number(s) C17034043;

5 There is probable cause to believe that Salvador Diaz-Garcia 2-6-94  
6 committed the crime(s) of Indecent Liberties (RCW 9A.44.100).

7 This belief is predicated on the following facts and circumstances:

8 This incident occurred on 6-25-17 at about 1900 hrs at 15421 Des Moines Mem  
9 Dr. Burien, King County, WA. V-AS was born on 12-12-02 and was 14 years old  
when this incident occurred. V-AS did not know S-Diaz and he was a stranger  
to her. S-Diaz was 23 years old when this incident occurred and lived in the  
same complex as V-AS.

10 On 7-10-17, after returning from vacation, P-Lisa reported her daughter V-AS  
had been sexually assaulted by a Hispanic male on 6-25-17.

11 On 7-11-17 your affiant spoke to V-AS. V-AS looked at a calendar verified  
12 this occurred on Sunday June 25th. V-AS said she knew it was Sunday because  
she had Volley ball the next day and was scared to walk to Volleyball. V-AS  
13 thought it happened at about 2100 hrs and it was still light out. V-AS said  
the unknown Hispanic male was wearing a grey short sleeve shirt.

14 V-AS said she went to get the mail on 6-25-17 at about 1900 hrs. V-AS saw the  
15 Hispanic male standing between 2 buildings, staring at her. V-AS walked to  
her apartment and when she got to the landing the same Hispanic male ran up  
16 behind her. V-AS said he tapped her on the shoulder and said something she  
could not understand. She said "Fuck" was in the sentence he said but what he  
17 said did not make sense. V-AS said she asked him to repeat himself, he did,  
and then grabbed her butt. V-AS said she yelled at him, cursing and he ran  
18 off towards Des Moines Memorial Drive. V-AS said she has never seen this  
Hispanic male before. V-AS said she went home and told her mom right away. V-  
19 AS said her mom went out looking for him and didn't find him.

20 V-AS described the Hispanic male as skinny, about 5'6"', short black hair,  
21 droopy eye, thick eye brows, some facial hair like he just shaved, goatee, in  
his late 20's, and a Spanish accent. V-AS said her mom reported it to the  
complex manager the next day and they went on vacation from July 28, 2017 for  
22 8 days.

23 I read V-AS the montage instructions, which she verbally said she understood  
and signed. I handed V-AS the montage which she looked at and told me "found  
24 it" I asked her what she found and she said this one and pointed at #2. I  
asked what was it about #2 and she said "he was the one who ran after me and



1 grabbed my butt." I asked from a scale of 1% to 100% sure, how sure was. V-AS  
2 said 100% sure. I asked her to sign her name, date, and write what percentage  
3 she was sure this was the person who grabbed her butt on the montage. V-AS  
4 said "I'll write 95% just to be safe."

5 On 7-12-17 P-Lisa said V-AS came home right after it happened, very upset.  
6 V-AS told that she heard someone running up behind her, they tapped her on  
7 the shoulder, said something to her with cuss words, and grabbed V-AS butt.  
8 V-AS told the man, "don't fucking touch me," and he ran off. P-Lisa called  
9 the apartment manager the next day from work and reported what happened. P-  
10 Lisa said the day after that V-AS heard that someone in the neighboring  
11 complex was assaulted in the gym. P-Lisa said they went on vacation until  
12 July 7th. P-Lisa said when they got back from vacation she called the  
13 apartment manager and was told that a suspect had been arrested for the  
14 assault at the neighboring complex. P-Lisa called 911 to report what occurred  
15 her daughter. P-Lisa said the incident occurred on Sunday 6-25-17 because the  
16 next day, Monday the 26th was the start of volley ball, and V-AS was afraid  
17 to walk to practice. P-Lisa called the apartment manager and reported the  
18 incident on Monday, 6-26-17. She said it was Tuesday, 6-27-17 that V-AS heard  
19 that a girl was assaulted at the Discovery Landing Apartments.

20 S-Diaz has been charged with Assault 2 for a separate incident that occurred  
21 at the Discovery Landing Apartments on 6-25-17 at about 2130 hrs/ KCSO  
22 #C17031435. Both victim's did not know S-Diaz. Both victims look similar.
